Paul continues his efforts of encouragement and direction to the church in Colossae as he progresses through his letter, specifically in chapter 2. With bold imagery he challenges the them to walk with Jesus in a specific way, gives them clear warnings, and ends with a reminder of who they are in Christ.

### Read Colossians 2:5-15

#### **OBSERVATION**

Verse 6 begins with the connector, "Therefore". What does vs. 5 say that then connects vs. 6?

In vs. 7, what four verbs does Paul use to describe how the Colossians ought to walk with Christ?

List the things Paul warns against being taken captive by in vs. 8. What are the things contrasted in vs. 10-14.

According to vs. 15, what three things are true regarding Christ's completed work on the cross?

#### INTERPRETATION

What does it mean to walk with Christ? Consider Galatians 5:16-17, 25

Describe the differences in the images Paul uses in vs. 7 as he encourages the Colossians regarding *how* they should walk in Christ.

According to vs. 8-10, what are the "footholds" Paul mentions Satan using to draw us from Christ? Describe how these things look in our lives today.

What does it mean that we are "circumcised in Christ," according to vs. 11? (Consider Gen. 17:1-4, Deut. 10:16, and Jeremiah 4:4)

Similarly, what does it mean to be "buried with him (Jesus) in baptism"? (See Mark 1:4 and Romans 6:1-10, 1 Cor. 10:1-2; 12:12-13 for insight)

In vs. 14 Paul references a "record of debt" and its "legal terms". What are these things and why was Christ the only one able to cancel them on our behalf?

As this section ends, read through other translations of vs. 15 to better comprehend what exactly Jesus accomplished on the cross.

What patterns can you establish today that will help establish you in your walk with Jesus?
