In the second half of chapter eight we see God withdrawing the waters and restoring creation, ultimately establishing a covenant with Noah in chapter nine. This section also shows God blessing Noah and providing new allowances to the life of man, as well as restrictions for other areas previously not expressed.

Explain how God's interaction with Noah and creation is a restorative account of the original creation of Adam in the Garden.

What is the difference between a covenant and a contract? Describe the details of the covenant God establishes with Noah. Consider who is involved and who is it dependent upon?

If Noah was truly righteous (6:9), does he *deserve* this kind of covenant? Keep in mind Genesis 8:21, 9:20 and Romans 3:23, then consider if *you* deserve this kind of treatment.

What does the covenant God makes with Noah, and all flesh (9:17), reveal about His character and heart for mankind? See Psalm 89:30-34.

APPLICATION

How does holding fast to God's promises given to us change how we experience joy and hope when facing difficulties AND/OR delights in life?
